2 Chris Deschamps: Hey how's it going  
3 Shawn Brant: Hey all right  
4 Chris Deschamps: Yeah I have somebody here who wants to talk to ya  
5 Shawn Brant: All right  
6 Chris Deschamps: Okay here ya go  
7 Julian Fantino: Shawn  
8 Shawn Brant: Yeah  
9 Julian Fantino: Commissioner Fantino calling how are ya  
10 Shawn Brant: Hey Mister Fantino I'm fine how are you  
11 Julian Fantino: I'm fine thank you Shawn we all wanna go to bed and  
12 call this quits so what's it gonna take to get ya to back  
13 off and and and and and work this issue through in a  
14 way that we don't have a potential for disaster  
15 Shawn Brant: Well uh unfortunately um ya know and and I I know  
16 Chris knows but uh um ya know I uh I I don't really  
17 uh have uh the ability to speak uh for everybody um  
18 ya know on uh

19 (simultaneously talking)  
20 Julian Fantino: (Unintelligible) Shawn you're a leader you're you're  
21 you're the guy that's organizing you're the guy that  
22 the media has been speaking with  
23 Shawn Brant: Yeah that's true  
24 Julian Fantino: You're you're don't don't don't don't off load uh ya  
25 know to other people I mean the reason I'm talking to  
26 you is because you're the leader of this and and so  
27 from one side to the other side let's let's call this quits  
28 enough now you've inconvenienced tens of thousands  
29 of people you made your message I mean what more  
30 do you want  
31 Shawn Brant: Yeah well it ya know uh  
32 Julian Fantino: The whole nation the whole nation's taken uh taken  
33 notice of what you've done here  
34 Shawn Brant: Yeah and I I ya know to be honest with ya I I don't  
35 disagree with that um  
36 Julian Fantino: What do ya want get everybody killed is that what  
37 you want  
38 Shawn Brant: No that's uh certainly not my intention and uh  
39 (unintelligible)  
40 (simultaneously talking)  
41 Julian Fantino: Well why don't we call it quits then we can all go  
42 home  
43 (simultaneously talking)  
44 Shawn Brant: Certainly certainly  
45 Julian Fantino: You've made your point  
46 Shawn Brant: Certainly not the mandate that I I came in with uh was  
47 uh  
48 Julian Fantino: I (unintelligible)  
49 Shawn Brant: To have anybody hurt and you know I mean uh um  
50 you know Mister Fontaine uh uh expressed uh his  
51 desire for uh for a peaceful day and ya know that's uh  
52 that's our mandate that's uh what we're trying to do  
53 and  
54 Julian Fantino: Yeah but it's not peaceful you have put uh thousands  
55 uh tens of thousands of people uh uh brought them to  
56 their knees this is a long weekend for a lot of people

57 children are out of school all kinds of plans have been  
58 disrupted and you're a family man I mean you you  
59 Shawn Brant: Yeah  
60 Julian Fantino: Can understand what this is costing (unintelligible)  
61 people who are no doubt supportive of your cause uh  
62 we're supportive of your cause but not this way  
63 Shawn Brant: Yeah  
64 Julian Fantino: We we can't we can't uh we can't uh even help you  
65 uh in in your struggle uh  
66 Shawn Brant: Yeah  
67 Julian Fantino: Ya know when when you put us uh in this kind of a  
68 predicament  
69 Shawn Brant: Yeah  
70 Julian Fantino: So  
71 Shawn Brant: I  
72 Julian Fantino: Can we call it quits  
73 Shawn Brant: Well I'll tell ya what I uh I'd uh like to do I'd uh um  
74 I'm gonna grab a couple hours sleep and uh right now  
75 I'm I'm uh ya know my head's a little uh I've been up  
76 for (inaudible) and I know you guys have been for a  
77 couple days and uh and uh I'll tell ya what I will do is  
78 uh in the uh um in the morning uh I will uh I'll uh  
79 broker your suggestion and uh and we'll uh we'll talk  
80 about it  
81 Julian Fantino: Shawn (inaudible) can can I can I uh implore upon ya  
82 to do it now Shawn you can't allow this to go on  
83 there's there's tens of thousands of people that are  
84 being fully inconvenienced here you've made your  
85 your point it's on national television everybody's  
86 talking about it uh you have been a star uh all day  
87 long ya ya you've got your your your uh your sound  
88 bites I mean Shawn there's no advantage for ya to  
89 continue this there there's all you're gonna do is tear  
90 away uh whatever gains you've made an whatever uh  
91 whatever issues you've articulated we we understand  
92 about the poverty the deprivation the the the  
93 children's suicide we know all of that nobody's  
94 arguing with you on this

95 Shawn Brant: Yeah

96 Julian Fantino: But you don't want to have those issues now buried in  
97 in Shawn the bad guy that inconvenienced tens of tens  
98 of thousands of people I mean you're losing the  
99 message uh this is this is this is destroying the  
100 message you've been trying to put out because people  
101 are now focused on how bad you are that you really  
102 don't care about tens of thousands of people you're  
103 just using your children and and and the deprivation in  
104 in in your community for your personal advantage uh  
105 people think you wanna be a star at all costs and and

106 Shawn Brant: Yeah

107 Julian Fantino: So so whatever message you've been putting out  
108 about children's suicides and poverty and and and the  
109 water and all of that that's all gonna be lost in the  
110 rhetoric where people are just gonna absolutely  
111 despise you and hate you they're not gonna hear  
112 anything you've said about all those wonderful causes  
113 you're talking about

114 Shawn Brant: Yeah

115 Julian Fantino: So I've talked to enough people now including a lot of  
116 people in in First Nations community they they are  
117 running for the hills because you're you're bringing  
118 them down you're bringing them down the all the  
119 gains that that you've made over the years uh and and  
120 now the struggle is is starting to have some effect uh  
121 you're destroying that because the message now is  
122 gone is gone from a cause to a vengeance a vindictive  
123 uh Shawn Brant is is is gonna bring Canada to it's  
124 knees well you're not gonna do it and and you're  
125 gonna be hated for it and and your cause you can  
126 speak about children committing suicide all you want  
127 nobody is gonna listen to you because you've got no  
128 more credibility if you keep this up

129 Shawn Brant: Yeah

130 Julian Fantino: And you know what I don't wanna I don't wanna get  
131 on your bad side but you're gonna force me to do  
132 everything I can within your community and

133 everywhere else to destroy your reputation  
134 Shawn Brant: Yeah  
135 Julian Fantino: I don't wanna do that I wanna help you deal with the  
136 suicides and whatever I've travelled to to uh to  
137 reserves uh I I know exactly what you're talking about  
138 I've seen it I've been to Kashechewan and and some  
139 of these other places I've been there I've been  
140 involved in  
141 Shawn Brant: Yeah  
142 Julian Fantino: I was involved a couple years ago in evacuating  
143 thirteen hundred people out of Kashechewan because  
144 of  
145 Shawn Brant: Yeah  
146 Julian Fantino: The conditions there  
147 Shawn Brant: Yeah  
148 Julian Fantino: So you you're talking to someone that's  
149 sympathetic here so I I'm imploring upon you to call  
150 it quits let's do it now  
151 Shawn Brant: Well I'll uh I'll make a deal with yeah I'll uh I'll uh  
152 certainly uh talk to people about that I'll uh  
153 Julian Fantino: Would you do it now Shawn  
154 Shawn Brant: Well I'll uh I'll start and uh I'll start by talking to  
155 people  
156 Julian Fantino: Can can we can we can we uh agree on pulling the  
157 plug on this so as we (unintelligible)  
158 (simultaneously talking)  
159 Shawn Brant: Well I  
160 Julian Fantino: Anybody hurt  
161 Shawn Brant: You know with the the greatest respect I I uh I can't  
162 make that decision on my own uh it's it's not within  
163 my uh it's not me  
164 Julian Fantino: Well you're not making up your own I'm helping you  
165 make it like we can be partners  
166 Shawn Brant: No I well I'm just saying that it's uh it's not within  
167 my power to do that and and really if I if I said that to  
168 you uh people would just tell me to fuck off anyway  
169 and and uh they'd tell me to go home uh and and it  
170 has to go through uh through the process and and uh

171 and what I am telling ya is is that I'll uh start talking  
172 to people about that  
173 Julian Fantino: So when can I expect to hear back from you  
174 Shawn Brant: Well I uh  
175 Julian Fantino: Chris can ya get a hold of Chris  
176 Shawn Brant: Yeah and uh if you uh  
177 Julian Fantino: How soon can we do that  
178 Shawn Brant: Well I'll start right now  
179 Julian Fantino: Okay wa when will you call back I I  
180 Shawn Brant: I'll  
181 Julian Fantino: I wanna keep in touch  
182 Shawn Brant: Yeah I'll I'll give Chris a call in uh an hour or so  
183 Julian Fantino: Well no don't don't give me an hour or so can we be  
184 more specific  
185 Shawn Brant: Well I'll uh give Chris a call in an hour  
186 Julian Fantino: In an hour so  
187 Shawn Brant: Yeah  
188 Julian Fantino: Let's be let's be clear so it's it's now two fifteen so at  
189 three fifteen you'll be calling Chris  
190 Shawn Brant: I'll be calling Chris  
191 Julian Fantino: So Shawn we've got a deal that we're gonna start  
192 moving this along are we  
193 Shawn Brant: Well uh we certainly have uh an understanding that uh  
194 and you know uh um I uh  
195 Julian Fantino: Shawn one one of our reserve uh uh one of the  
196 reserves up in in the north country here had three  
197 suicides just recently three kids  
198 Shawn Brant: Yeah  
199 Julian Fantino: Who killed themselves  
200 Shawn Brant: No I know I know  
201 Julian Fantino: So so let's not get that message convoluted with all  
202 this nonsense that we're having to deal with here  
203 blockades and all that stuff let's let's let's stay on  
204 message let's let's stay on and we can all do this  
205 together I mean you got issues to deal uh and and and  
206 I know that you'll face that but let's stay on message  
207 le let's not dilute the message with all this hatred that  
208 people that are gonna develop for you and what

209 you're standing for  
210 Shawn Brant: Yeah  
211 Julian Fantino: So you look it if Shawn Brant is gonna be credible  
212 you're gonna have to make sure you don't kill the  
213 message you're trying to put put across  
214 Shawn Brant: Yeah  
215 Julian Fantino: And you do  
216 Shawn Brant: No yeah  
217 Julian Fantino: So  
218 Shawn Brant: I I don't disagree with that  
219 Julian Fantino: Well let's get on with then okay so give Chris a call  
220 uh say uh at uh three thirty or three fifteen three  
221 fifteen or by three  
222 Shawn Brant: Uh three three fifteen  
223 Julian Fantino: Three fifteen okay Shawn  
224 Shawn Brant: Yeah okay  
225 Julian Fantino: No don't you go to bed because I'm not  
226 Shawn Brant: (laughs) Okay I'll uh  
227 Julian Fantino: All right  
228 Shawn Brant: I told Chris I was gonna steal a couple hours but I'll  
229 uh I'll start that process  
230 Julian Fantino: You know if you pull this off I'm liable to say that  
231 your your issues are are are are critical and they're  
232 important and and I'll speak to that but uh if you don't  
233 then I'm gonna go the other way and I'm gonna say  
234 that you're just destroying and you're abusing you're  
235 using the people and you're you're actually being a  
236 mercenary about it using the suicide of children and  
237 all those those legitimate uh issues and you don't want  
238 that because I think I can I can I can play the media  
239 routine like you do  
240 Shawn Brant: Hey Mister Fantino uh  
241 Julian Fantino: Right  
242 Shawn Brant: I I put two of my own babies in the ground um  
243 Julian Fantino: I'm sorry  
244 Shawn Brant: It this this isn't an issue that uh that doesn't concern  
245 me and affect me deeply and and  
246 Julian Fantino: Yeah I I know but you don't you don't wanna lose

247 you don't know what you don't wanna lose that in in  
248 in in the rhetoric of other causes where people are  
249 concerned about getting from point A to point B and  
250 Shawn Brant is is is public enemy number one this  
251 weekend so let's turn that around and let's stay on  
252 message  
253 Shawn Brant: All right  
254 Julian Fantino: Okay  
255 Shawn Brant: Okay  
256 Julian Fantino: Three fifteen  
257 Shawn Brant: Thanks  
258 Julian Fantino: Bye  
259 Shawn Brant: Bye now

2 Julian Fantino: Shawn  
3 Shawn Brant: Yeah  
4 Julian Fantino: Commissioner Fantino calling  
5 Shawn Brant: Hey  
6 Julian Fantino: How are you  
7 Shawn Brant: Good  
8 Julian Fantino: You missed the deadline I thought you were gonna  
9 call me back at three fifteen  
10 Shawn Brant: Hey I I've been uh doing uh what I said I was gonna  
11 do and I and  
12 Julian Fantino: How ya making out  
13 Shawn Brant: Well it it's coming along ya know I to be honest with  
14 ya running back and forth and having the wife bring  
15 me the phone and and interrupting uh really isn't that  
16 helpful uh

19 Julian Fantino: Shawn we got a lot of pressure here

20 Shawn Brant: Yeah well

23 the next little while I'll let ya take all the credit all  
24 right  
25 Shawn Brant: Well ya know I I to be honest with ya um ya know uh  
26 we had an agreement the last time and uh and it was  
27 an uh uh agreement on the tracks and there was an  
28 agreement for immunity and and it was my  
29 understanding  
30 Julian Fantino: Well no no no  
31 Shawn Brant: That uh that there was uh uh pressure from uh you and  
32 and uh direction to to lay the charges against me  
33 Julian Fantino: Oh no what  
34 Shawn Brant: Um ya know I I mean so when when  
35 Julian Fantino: Shawn there's no  
36 Shawn Brant: We're talking about building a relationship and  
37 building trust um  
38 Julian Fantino: I've never given immunity in my life to anybody  
39 Shawn Brant: Well certainly your officers did  
40 Julian Fantino: Well but I can't speak to that right now Shawn we we  
41 have another emergency here and and let's let's deal  
42 with this one now uh when I said I'll let ya take the  
43 credit you you can tell the media that you you decided  
44 to pull the plug otherwise uh it it won't look that  
45 pretty  
46 Shawn Brant: Well you you're asking me to uh talk to people and  
47 and convince them of uh of uh uh your word and your  
48 integrity and and and to be honest with you ya know  
49 uh people are throwing it right back in my face and  
50 they're saying uh Shawn didn't you get fucked the last  
51 time and and isn't this the uh uh is this the same uh  
52 person who uh who ordered those charges and and ya  
53 know it it it's not an easy go I mean there there's not a  
54 lot of trust between us and and I'm not speaking  
55 Julian Fantino: Well  
56 Shawn Brant: Personally I'm I'm speaking to to the organization  
57 and

58 Julian Fantino: Shawn your whole world's gonna come crashing  
59 down on this issue and and uh you can't get away  
60 with uh with holding uh tens of thousands of people  
61 hostage and get away with it so ya know let let let's  
62 not screw around any longer you gotta get on with this  
63 because if you don't uh your credibility is gonna be  
64 absolutely zero here you are speaking about the plight  
65 of children and then you got children there helping  
66 you in the blockade or whatever and women and all  
67 that jazz so you're not gonna look so pretty when this  
68 is all done Shawn

69 Shawn Brant: Well it

70 Julian Fantino: Why why don't why don't we just call it quits and you  
71 you can't get anymore uh exposure than what you've  
72 got you've put these issues across you've done a great  
73 job of the sound bites and that I mean ya know you  
74 you gotta you you you gotta believe that you're you're  
75 day has come ya know enough now let's all go home  
76 come on

77 Shawn Brant: Are ya gonna let me do my job

78 Julian Fantino: Yeah hurry up though uh

79 Shawn Brant: Okay

80 Julian Fantino: When are you gonna call me back

81 Shawn Brant: I'll call ya back as soon as I have some answers

82 Julian Fantino: Okay call Chris or yeah but that could be (inaudible)

83 Shawn Brant: Hey

84 Julian Fantino: Two o'clock this afternoon

85 Shawn Brant: Ya ya know I there's a there's a process that I gotta  
86 work through and and uh and that's just the way that it  
87 is and and

88 Julian Fantino: I I guess I have to tell ya that I have a process to work

90 Shawn Brant: Oh and I understand that I understand that I I also  
91 Julian Fantino: I'm trying to meet you halfway Shawn

3 Chris Deschamps: Good morning Shawn how are ya  
4 Shawn Brant: I'm good thanks  
5 Chris Deschamps: Good uh the Commissioner wants to talk to ya  
6 Julian Fantino: Morning Shawn  
7 Shawn Brant: Good morning Mister Fantino  
8 Julian Fantino: How ya doin  
9 Shawn Brant: Not bad thanks  
10 Julian Fantino: Are we makin any progress  
11 Shawn Brant: Well we're sitting here uh speaking uh shortly we're  
12 just uh burning some tobacco and we'll be speaking  
13 uh again with uh Constables Ron and uh Ron Maracle  
14 and uh Jason Brant so yeah I think we're makin some  
15 progress  
16 Julian Fantino: Oh I got some noise here Shawn uh there's a a thing  
17 that I wanted to bring your attention that you need to  
18 know about

19 Shawn Brant: Yeah

20 Julian Fantino: That there's um a Mohawk Council of Akwesasne uh  
21 office of the Grand Chief be aware of uh some major  
22 events that they're having there today including the uh  
23 the appearance of uh former Prime Minister uh Martin  
24 and and there's other dignitaries coming there uh

25 Shawn Brant: Yeah I I am aware of that

26 Julian Fantino: Louise McDonald Clan Mother's gonna be speaking  
27 there and all a that M P P's and so forth

28 Shawn Brant: Yes sir

29 Julian Fantino: Uh in any event uh you're running a risk of of  
30 screwing that up for them you know that eh

31 Shawn Brant: Well I don't think uh there should be a risk to uh  
32 Mister Martin because of what's going on up here but  
33 uh

34 Julian Fantino: Well well we've heard we heard there is and that's  
35 why I'm tryin to get to you to let you know about this  
36

37 Shawn Brant: Hm

38 Julian Fantino: Uh we heard that uh the thing may go up in smoke um  
39 because of uh all that's happening here uh and and  
40 you have people in the in the uh Akwesasne  
41 Community are are quite upset that that the word  
42 we're getting they're quite uh offended by uh the  
43 traditional people feel quite offended by what's goin  
44 on and this is a a word we got from a number of  
45 people so I don't know if you wanna push your luck a  
46 little bit too much here because you're gonna get a  
47 whole lot of people gonna (inaudible) (unintelligible)

48 Shawn Brant: We certainly don't want to uh upset the uh apple cart  
49 in Akwesasne but uh ya know I I know that that's a  
50 strong community that's uh takin some harsh stands in  
51 the past and (inaudible) and there's the uh have uh  
52 shot their own people as a matter of fact and and uh  
53 I'm I'm not sure if uh they would see uh uh uh  
54 participation in the Day of Action as being uh  
55 detrimental to whether or not they have a uh an  
56 (unintelligible) at the bottom of the bridge but uh ya

57 know I I'll certainly uh take it into consideration  
58 Julian Fantino: Well wuh we this is the word that we got and uh I  
59 thought you should take that into account because uh  
60 it looks like they're quite upset they're annoyed with  
61 what's goin on and um they feel that this is  
62 jeopardizing their uh their efforts here it took them an  
63 awful lot of work to get Mister Martin and some of  
64 the other dignitaries that to come to this uh event and  
65 Louise McDonald the Clan Mother is speaking there  
66 so the uh they're they're very concerned about what's  
67 goin on then they've let us know this uh through our  
68 own contacts so uh I I think that you're running an  
69 awful risk now of this thing goin south on you  
70 Shawn Brant: Yeah well I I certainly appreciate that I I know Louise  
71 McDonald and and um ya know I I may not subscribe  
72 to the same philosophies to the Long House that she  
73 attends I I  
74 Julian Fantino: Yeah  
75 Shawn Brant: More uh subscribe to the Hogansburg House but uh I I  
76 do know her and I have respect for her and and  
77 certainly Mister Martin uh uh has made some uh good  
78 commitments with respect to uh his future and his  
79 relationship with First Nations people and uh I can  
80 promise you that uh I I'll certainly um uh bring that  
81 up when uh when we're having discussions which  
82 we're about to do uh shortly and and I know uh  
83 Constable uh Ron Maracle and Jay Brant are patiently  
84 waiting for me to uh uh to get to those discussions and  
85 and um and I'm uh anxious as well to uh to engage in  
86 those talks so if um if we could then then I uh I I'd  
87 certainly like to do that and uh maybe then I'll be able  
88 to provide you with some uh answer that uh you might  
89 find satisfactory  
90 Julian Fantino: I think we're running out of time Shawn uh ya know  
91 we've been back and forth all night on this and uh  
92 we've got an awful lot of very very angry people uh  
93 who are absolutely uh beyond themselves with what's  
94 goin on and uh ya know we we we just have to close

95 shop here we just can't go on any longer to be honest  
96 with you  
97 Shawn Brant: Yeah well ya know I I certainly appreciate that and  
98 and I know that uh sometimes the uh the wheels turn  
99 slowly but uh ya know it's important that uh wuh ya  
100 know we came in here on a consensus and and we  
101 need to resolve this on a consensus and um ya know I  
102 I'm sure Louise uh would uh uh would advise as well  
103 that it's important to consult with uh Elders and uh  
104 Spiritual Advisers as well so uh we're we're uh  
105 endeavouring to do that now and and we're ready to  
106 sit down and have those discussions and and uh we'll  
107 do it uh as swiftly and as responsibly as uh as within  
108 our power  
109 Julian Fantino: Well Shawn uh we run outta time I can tell ya that  
110 much so uh I don't know how quickly you you can or  
111 you're willing to do things but uh uh we've reached  
112 the end of the rope here uh we we just have no more  
113 latitude at all Shawn so  
114 Shawn Brant: Yeah  
115 Julian Fantino: Just be on notice that uh that we we we just uh uh can  
116 no longer wait and wait and wait uh there's just too  
117 much uh at stake here you can't hold uh ya know hun  
118 tens of thousands of people hostage like you're doin  
119 and and and expect that we all be patient with you so  
120 ya know consequences are consequences you're a big  
121 boy and and uh and just remember you're also  
122 dragging uh along with you an awful lot of innocent  
123 people and uh I hate to see that happen where people  
124 are are then punished because of of your lack of uh of  
125 listening to all the advice that we've been trying to  
126 give you  
127 (simultaneously talking)  
128 Shawn Brant: Well certainly uh it's not my intention to uh uh create  
129 uh that type of animosity amongst uh the people who  
130 are travelling and and uh we're  
131 (simultaneously talking)  
132 Julian Fantino: (Unintelligible)



133 Shawn Brant: We're taking that into consideration and and we're  
134 looking at uh bringing this issue to a resolve and and  
135 uh ya know I I I think that um ya know there uh  
136 certainly needs to be um ya know at least uh an  
137 opportunity to have those discussions uh uh rather  
138 than um  
139 (simultaneously talking)

140 Julian Fantino: We've given you given you the uh we've given you  
141 that opportunity uh for for the last uh numbers of  
142 hours um this is not a big issue you're in charge uh  
143 you're responsible you can pull the plug uh uh you  
144 know darn well that you're not supported by a whole  
145 lot of people in First Nations so

146 Shawn Brant: Well ya know with with the greatest respect Mister  
147 Fantino we we have uh ya know uh two officers here  
148 that uh we've been engage engaging in discussions  
149 with and and we have a good relationship with them  
150 and and they're certainly expressing uh similar uh  
151 view points that uh that you're bringing up now and  
152 uh with the greatest respect uh I'd like the opportunity  
153 to uh pursue those with those officers and and I think  
154 it might be more appropriate if they conveyed that uh  
155 message back to you and and we uh we dealt uh  
156 directly with our officers uh we uh we're satisfied  
157 with their honour and integrity and

158 Julian Fantino: (Unintelligible) (inaudible) (unintelligible)

159 Shawn Brant: We'll certainly uh listen to uh to to their suggestions  
160 because they are community members and First  
161 Nations people who uh are also uh reeling from

162 Julian Fantino: Shawn you're missing the point  
163 (simultaneously talking)

164 Shawn Brant: Uh the circumstances that we live in

165 Julian Fantino: You're missing the point it's not about your officers  
166 you you are blocking land that is not yours you're  
167 you're interfering with the safe passage and free flow  
168 of people's entitlement to travel along the various  
169 highways that are not on your on your uh Reserve  
170 they're not part of your land uh you've you've come

171 out to create great inconvenience to a whole lot of  
172 people that uh that have got no issue with you uh you  
173 have made it an issue for them so uh givin Tyendinaga  
174 a a very bad name the whole community's affected uh  
175 you're taking their the decent people uh down uh with  
176 you the reputation is is gonna be worn by all I do not  
177 see any responsibility towards all those fine people  
178 that are are not in agreement with you but who are  
179 part of your community who don't uh who don't  
180 appreciate what you're doin I mean (unintelligible)  
181 Shawn Brant: But I yeah I I did have uh and we all did we had  
182 discussions with um uh some of those people I I  
183 believe there was uh four individuals who who came  
184 and they delivered a message for me this morning and  
185 uh certainly we listened to them and and um and uh I  
186 think that uh um ya know we we should just stick with  
187 the uh the proper course of uh discussions and and uh  
188 again with the greatest of respect uh I'd uh just like  
189 the opportunity to to do that in uh the way that that we  
190 have right now and and uh and I I certainly trust the  
191 gentleman and and we're uh uh we're both confident  
192 that uh a reasonable uh resolution can be reached in a  
193 short length of time and and uh we're we're not  
194 asking for uh um ya know a great deal where we're  
195 simply only asking for the opportunity to uh to engage  
196 in those discussions and to do it in the most  
197 appropriate way  
198 Julian Fantino: Shawn uh because of the uh traffic situation people  
199 having to be rerouted we've already had two persons  
200 injured in in in motor vehicle collisions and uh you're  
201 responsible for that uh so how much more pain and  
202 suffering uh grief and aggravation do you want to  
203 cause decent law abiding citizens uh how much more  
204 of this do you want on your conscience Shawn  
205 Shawn Brant: Well I I certainly (unintelligible) want that  
206 (simultaneously talking)  
207 Julian Fantino: But you're gonna wear it you're gonna wear it Shawn  
208 all the good things that you think you're doin uh and

209 you've been trying to do the good things you've been  
210 saying they're all going down the tubes uh you're not  
211 gonna be a hero for long trust me

212 Shawn Brant: Okay

213 Julian Fantino: If you keep this up so

214 Shawn Brant: Okay

215 Julian Fantino: Enough is enough now uh you've worn our patience  
216 down uh the tolerance of the public is saturated  
217 there's no more charity and no more no more putting  
218 up with this uh ee I'm I'm I'm now warning you to  
219 pull the plug on this because at the end of the day  
220 you're gonna be the big loser as will the communities  
221 you think you're representing because they're not  
222 with you

223 Shawn Brant: I certainly appreciate after you're concerns and and I  
224 share them as well and uh we'll uh have a um an  
225 answer back and a solution to to the issue uh I'm  
226 confident uh in a very short length of time uh we uh  
227 we're simply about to uh

228 Julian Fantino: Shawn wuh we're nuh

229 Shawn Brant: Start burning tobacco and and uh that'll allow us

230 Julian Fantino: Shawn

231 Shawn Brant: To uh have some clarity on the issue

232 Julian Fantino: Shawn we're not negotiating anymore we've done it  
233 all night I'm now telling you for the sake of uh all  
234 that's decent and holy and the things you're trying to  
235 achieve and and and to ensure that the reputation and  
236 the credibility of of of First Nations people which I  
237 think is being very severely damaged I I'm now  
238 telling you pull the plug or you will suffer grave  
239 consequences

240 Shawn Brant: Okay

241 Julian Fantino: Okay

242 Shawn Brant: Thank you sir

243 Julian Fantino: Thank you

244 Shawn Brant: Bye now

245 Julian Fantino: Bye
